### **Terms and Conditions**

These are the terms and conditions subject to which we allow you to use Our Website. By visiting or using Our Website, or make an order, you agree to be bound by them.

We are Aplus Physio Limited , trading as A+ Physio, a company registered in New Zealand.

You are: Anyone who uses Our Website or buys from us in any circumstances.

### **1. Basis of contract**

- 1.1. In entering into this contract you have not relied on any representation or information from any source except the definition and explanation of the Products given on Our Website.
- 1.2. If you use Our Website in any way and make an order on behalf of another person you warrant that you have full authority to do so and you accept personal responsibility for every act or omission by you.
- 1.3. Subject to these terms and conditions, we agree to provide to you the Products described on Our Website at the Prices we charge from time to time.
- 1.4. You acknowledge that you understand exactly what is included in the Products and you are satisfied that the Products you intend to buy are

suitable and satisfactory for your requirements.

- 1.5. The contract between us comes into existence when we receive payment from you for a Product.

OR

- 1.6. The contract between us comes into existence only when we write to you to confirm that we agree to provide to you the Product you want. Your payment does not create a contract. If we decline to provide a Product we shall immediately return your money to you.
- 1.7. We do not offer the Products in all countries. We only supply particularly for the city of Dunedin in New Zealand.
- 1.8. Subject to all the terms in this agreement, we authorise you to access and use Our Website and to download and print a small part of the content. This licence is conditional not only on your compliance with all of the terms of this agreement, but also on your using the Content only as intended by us, for your use in connection with the Work.
- 1.9. We may change this agreement and / or the way we provide the Products, at any time. If we do:
  - 1.9.1 the change will take effect when we post it on Our Website.
  - 1.9.2 you agree to be bound by any changes. If you do not agree to be bound by them, you should not use Our Website or the Products.
- 1.10. Prices for Products which you may buy as a New Zealand consumer are inclusive of GST.
- 1.11. Products are to be picked up at our address unless you contact us for special arrangements which may incur additional charges.
